In such situations, the PGIM will be reluctantly compelled to request the relevant authorities/bodies to nominate another suitable member to the Board of Study. Please also note that you are required to inform the PGIM if you resign or retire from active service, or take long leave (including sabbatical leave), as your tenure as a member of the board would then cease.

I kindly request you to be mindful of these facts and wish to inform you that your contribution as a member of the Board of Study will be greatly appreciated by the PGIM.
