







































Comments/ suggestions on visits and the end appointment exam

Transport issues led us to request the cancellation of one appointment. While it was challenging, you kindly considered our request, for which we are very grateful.

About the clerkship exam, Before the exam, I stayed up all night, worried that it would be very difficult. However, the exam focused on practical knowledge. On the OSPE, questions with documents were not clear, and I couldn't even read the Pap smear form question within the limited time.anyway after the exam, I slept the whole day peacefully.

We understand the challenges you face with limited lecturers, and we appreciate your efforts. However, we hope you can also consider our concerns.


Thank you Sriyani madam, on every appointment you attended you always tried teach new things and appreciated us as far as u can.
